P.E.I. 4-H Trust Criteria

The following information was taken from the PEI 4-H Trust Deed.

ii. (a) Purposes

The Trustees shall keep the capital of the Fund invested, and the net income therefrom (being the gross income less Fund administrative expenses) shall be available for distribution to the Council according to the terms hereof. The Council may apply to the Trustees for funding of the following:

- i. programs and services of benefit to the 4-H movement, its members and leaders, which are additional to those provided by the Prince Edward Island 4-H Council and current funding sources;
- ii. expenses associated with the promotion, development, or completion of any 4-H activity, such expenses to include salaries, travel, accommodation, meals, rental of facilities or equipment and the like;
- iii. generally, for the promotion and continued development of 4-H programs in the Province of Prince Edward Island.

II Priorities of Fund

- A. The Trustees shall give first priority to such applications by the Council as involve the development, initiation, and support of new 4-H programs or activities, provided that the Fund may be used to support existing programs or activities if the Trustees are satisfied that Council has exhausted all other reasonable means to obtain the funds, and the support of such programs or activities is found by the Trustees to be warranted;
- B. the Fund shall be used to support a variety of 4-H programs and activities; and
- C. the Fund shall comply with the terms attached to any donations or bequests it accepts.

II Council Authorization

Only programs, projects, and activities authorized by the Council may receive monies from the Fund.
